**Memorandum of Understanding (MoU) between
Tikur Anbessa Specialized Hospital
&
The Yeabe Medical Center & Rehabilitation, Ltd**

This Memorandum of Understanding (the “MoU”) is made as of the ___ day of August 2018 by and between Tikur Anbessa Specialized Hospital (hereafter referred to “**TASH, or the hospital**”), Zambia St, P.O. Box 1234, Addis Ababa and Yeabe Medical Center & Rehabilitation, Ltd (hereafter referred to “**the organization**”), not-for-profit corporation with its principal place of business at P.O. Box 2824, Lilburn, Georgia 30048.

WHEREAS, the organization is a 501 (C) 3, operating under the guidelines as published by the Internal Revenue Service of the United States of America. The EIN number for Yeabe Medical Center & Rehabilitation, Ltd is **82-0732696**. The organization’s business was incorporated on March 22, 2017 in the State of Georgia, USA. **TIGIST A DEMISSE** is the incorporator and CEO of the organization. The organization received its 501 (C) 3 letter from the Internal Revenue Services of the United States on October 24th 2017 with an effective look back date of March 22nd 2017, the date of incorporation.

WHEREAS, organization has signed MoU with Federal Ministry of Health of Ethiopia in April 23rd 2018 to partner with Government of Ethiopia to build and operate a 500-bed capacity comprehensive hospital. Meanwhile, the MoU also indicates that the organization will provide technical support and material donations to public health facilities.

WHEREAS, the organization is authorized to solicit donations and provide charitable fundraising activities in the United States and certain foreign countries, including fundraising via internet and mobile telephone technology, and solicitation of grants from foundations and governmental agencies. The Yeabe Medical Center & Rehabilitation, Ltd is engaged in, among other things, **establishing Collaborative Partners to accomplish short-term goals:**

1. The Yeabe Medical Center & Rehabilitation, Ltd
 - Partnering with TASH in establishing dialysis service in the hospital. The support includes but not limited to renovation of infrastructure, donation of equipment, furniture and water treatment unit.
 - The organization will also partner with the hospital in any other service delivery area.
 - The organization has to facilitate donated equipment to the hospital have to be of quality assured and certified by authority(ies).
 - The organization will provide technical support (trainings) related to the dialysis machine operation to the technicians, nurses and physicians.
 - The organization will facilitate continuous supply of consumables for dialysis and other renal services.
 - The organization will bear operational expenses to set up dialysis unit and supply of medical devices & consumables.
2. Tikur Anbessa Specialized Hospital
 - TASH shall be responsible to deploy technicians, nurses, physicians and other staff.
 - TASH will allocate adequate space to set up dialysis unit

3. Both parties agree to prepare joint plan to set up the dialysis unit and identify other collaborative areas.
